- **Intramuscular Influenza – High Dose** for 65 and older (all retail pharmacies, physicians and Convenience Care Clinic) - **exception CVS is not contracted for Flud Quad High Dose CPT 90694**
- **Intradermal Influenza – Smaller Needle** for ages 2-49 (Available from physician, Convenience Care Clinics and all nationally contracted Retail Pharmacies)
- **Intranasal Influenza– Flu Mist Quadrivalent** for ages 2-49 (Available from physician, Convenience Care Clinics and all nationally contracted Retail Pharmacies)
- **Pneumonia (PPSV23 – Pneumovax)** - Available from physician, CCC and all nationally contracted Retail Pharmacies
- **Pneumonia (PCV13 - Prevnar 13)** - Available from physician, CCC and all nationally contracted Retail Pharmacies

- **Hepatitis B** - Available from physician, CCC and all nationally contracted Retail Pharmacies **[pharmacy age restriction 3 years and older]**
- **HPV - Human Papillomavirus-** (Available from physician, Convenience Care Clinics and all nationally contracted Retail Pharmacies **[pharmacy age restriction 3 years and older]**)
- **Zostavax (Shingles Vaccine)** - Zostavax is no longer available for use in the United States, as of November 18, 2020
- **Shingrix (Shingles Vaccine)** Available from physician, CCC and all nationally contracted Retail Pharmacies. UHC fully insured medical policy allows for members age 19 and older to receive vaccine, for DOS 04/01/22 and after. For DOS prior to 4/1/22 to be covered the member must be 50 or older.
- **MMR** - Available from physician, CCC and all nationally contracted Retail Pharmacies **with the exception of Walgreens, Albertson, Safeway, New Alberston, United Supermarkets [pharmacy age restriction 3 years and older]**
- **MMRV** - Available from physician, CCC and all nationally contracted Retail Pharmacies **with the exception of Walgreens, Albertson, Safeway, New Albertson, United Supermarkets [pharmacy age restriction 3 years and older]**
- **Varicella** - Available from physician, CCC and all nationally contracted Retail Pharmacies **with the exception of Walgreens, Albertson, Safeway, New Albertson, United Supermarkets [pharmacy age restriction 3 years and older]**
